#### CANTON WOMAN KILLED IN CRASH **ON INTERSTATE ROUTE 90**

HARPERSFIELD TOWNSHIP - The Ohio State Highway Patrol's Ashtabula Post is investigating a one-vehicle crash that resulted in one fatality.

The crash occurred around 7:57 p.m. July 5 on Interstate Route 90 near mile marker 219 in Harpersfield Township. Unit #1 was a Grey 2003 Ford Explorer SUV, driven by

Keith Rochefort, age 44, of Canton. Unit #1 was traveling east on Interstate Route 90. Unit #1 driver lost control of the vehicle and overturned several

times before coming to rest. A passenger, Karly Steele, of Canton, Ohio, was partially ejected during the crash and sustained fatal injuries.

It does not appear that seat belts were in use by any of the occupants in the vehicle. At this time, it does not appear

that alcohol and/or drugs were involved. This crash remains under investigation.

TYLER JOSEPH BARR was indicted on four counts of fourth-degree misdemeanor. complicity in the commission of an offense, one a first-degree felony, one a second-degree felony, one a third-degree felony and one a first-degree misdemeanor.

JAMES O. GOOD III was indicted on one count of aggravated trafficking in drugs, a second-degree felony; one count of aggravated possession of drugs, a second-degree felony; and one count of selling, purchasing, distributing or delivering dangerous drugs, a fifth-degree felony.

SCOTT MICHAEL ARKKELIN was indicted on one count of failure to comply with an order or signal of a police officer, a third-degree felony; one count of obstructing official business, a fifth-degree felony; one count of carrying a concealed weapon, a first-degree misdemeanor; and one count of illegal use or possession of drug paraphernalia, a

LARRY A. GRIMMETT was indicted on two counts of operating a vehicle under the influence of alcohol, a drug of abuse or a combination of them, both fourth-degree felonies; one can of failure to reinstate a license, an unclassified misdemeanor; and one count of violation of lanes of travel on roadways, a minor misdemeanor.

## Ashtabula County Targeted RECLAIM update

In 2011, the Ashtabula County Juvenile Court was approached by the Ohio Department of Youth Services (ODYS) to participate in programming to better serve youth and families. The goal was to decrease commitments to the ODYS prison system.

This presented a major shift in both philosophy and practice within the Court. The court described experiencing a "revolving door," meaning that once it sent a youth to ODYS, that youth continued to return to court, and in many cases, was revoked back to ODYS.

Each year through the Targeted **RECLAIM** program, the Court added new programming to meet the needs of the youth and families of the county.

In 2015, newly elected Judge Albert S. Camplese continued local service expansion through a Competitive Reclaim grant for Multi-Systemic Therapy through a regional approach with surrounding counties, Trumbull, Mahoning and Geauga.

Along with building capacity for WRAP with local collaborating agencies, staff were trained in Trauma Informed Care (TIC). Fiscal Year 2015 had two admissions to ODYS. Local detention admissions for the annual year was 243. In 2016, the court had four admissions to ODYS and 233 local detention admissions.

The Court continued to add programming and joined the state effort of the Juvenile Detention Alternative Initiative (JDAI) with the Annie E. Case Foundation in 2017. Fiscal Year 2017 had zero admissions to ODYS. Local detention admissions for the year were 184. Fiscal Year 2018 had zero admission to ODYS. Local annual detention admissions for the year were 62.

In 2018, the Juvenile Court implemented its Diversion Program. In 2019, the Youth Detention Center closed its doors and the Resource Center began its operations as a 24/7 gateway to services for youth and families.

Ashtabula County continues to embrace evidence based practices in all of its operations. These practices are objective, and serve to preserve and rehabilitate youth and families while keeping the public safe here in Ashtabula.

In 2020, the Court has admitted nine youth to detention and one youth to ODYS.

U.S. 20 & STATE ROUTE 45 BRIDGE REPLACE-**MENTS IN AUSTINBURG & SAYBROOK TOWN-**SHIPS: State Route 45 between State Route 307 and Clay St. is CLOSED through mid-August for a bridge replacement. The detour is State Route 307 to State Route 534 to State Route 84. Estimated completion, mid-October 2020.

STATE ROUTES 7 & 531, RESURFACING, CON-NEAUT: State Route 7 between Jackson St. and State Route 531 and State Route 531 between State Route 7 and Whitney St. has various lane restrictions. Estimated completion, late October 2020.
